

## Scheduled Town Council Meetings for 2018

All Regular Town Council meetings are scheduled on Thursdays (usually the 4<sup>th</sup> Thursday) at 9:00 a.m. in the Council Chambers at Town Hall, located at 6001 N. State Road A-1-A in Indian River Shores, Florida.
