Dear Residents and Interested Parties,

It's a newsy month! Here's what happened at the Florida Department of Transportation open house **yesterday** about A1A, [directly from the website](#):

- An FDOT meeting was held to discuss the A1A milling & resurfacing project on July 10.
  - The **East-side sidewalk** was an item of concern by a few residents, partly due to a false rumor that it was the Town's idea, rather than an FDOT policy requirement. Also, the neighborhoods that have landscaping or ground-level lighting *in the right of way* will be required to remove them to prevent damage and obtain an FDOT permit to replace them. Residents may walk in the sun or shade by choice soon.
  - The **bike paths** were another concern, with assurance that they will continue to be 4' wide. Flashing beacons for crosswalks at Sea Grape and Turtle Trail access crossings will be installed.
  - **Timing of paving**, which will be accomplished at night or off-peak hours to minimize disruption to traffic for our convenience. It is the smaller part of the project compared to the sidewalks.
  - *The project is in the design stage.* **Comments are welcomed** by the end of July, and not later than August 5. Plans will be reviewed and finalized by October.   - Separate from this project is the fully actuated (weight-tripped or pedestrian button) traffic light at Fred Tuerk Drive/ Beachcomber Lane as recommended for safe crossing by the Florida Dept. of Transportation. It is expected to be functional by the end of 2018.
- We were informed by Republic Services **today** that the **brush pick up day is changing to Friday effective August 1**. Please see the **attached flyer**.
- As a reminder, the **Safety & Weather Alerts page** has updated information on storms as they occur.
- **Technological renovation** to the Council Chambers began today. Soon you will be able to view any presentations on large screens listen through an improved sound system. Our current equipment probably dates back longer than 20 years.
- Please remember the [rules for turtle season](#). Many nests already are marked on the beaches.
