The meeting was called to order by Vice Mayor Weick at 8:01 a.m. The Pledge of Allegiance and invocation were recited and the roll call is as reflected above.

2. **Second and Final Reading, Ordinance 520**

Mr. Clem announced the first reading was performed on September 11, and this second reading has been properly advertised. It was first discussed at a Workshop on March 26, 2015, widely disseminated and reviewed. There have been minor clarifying amendments made to Section 55.07 (c) Recording Requirements, to state the utility trust account is held by the Town Treasurer rather than the Town Clerk. This Ordinance becomes effective immediately upon passage. The ordinance was read by title by Mr. Clem as follows:

ORDINANCE NO. 520

AN ORDINANCE OF THE TOWN OF INDIAN RIVER SHORES, FLORIDA, PROVIDING FOR THE REGULATION OF ELECTRIC UTILITIES SERVING WITHIN THE TOWN WHOSE RATES AND REVENUE REQUIREMENTS ARE NOT REGULATED BY THE FLORIDA PUBLIC SERVICE COMMISSION; PROVIDING FOR SEVERABILITY OR REPEAL OF CONFLICTING ORDINANCES; PROVIDING AN EFFECTIVE DATE.

A motion to approve the second and final reading of Ordinance 520, Regulation of Electric Utilities Serving Within the Town not regulated by the Florida Public Service Commission, was made by Councilman Slater and seconded by Councilman Ochsner. A roll call vote resulted in the motion passing 3-0.
