### Required information for submission:

- Tree Survey with structure overlay
- Erosion Control Plan (SWPP Plan)
- Legal Description/Recorded Warranty Deed
- Site Plan or Subdivision Plat
- Total Lot areas of <u>one acre or more</u> require a Town Stormwater Application in addition to a State NPDES permit.

#### **NOTES:**

- Request for Land clearing permits may allow the maximum clearing, grubbing and vegetation removal as deemed allowable by ordinance and approved by the Building Department.
- By submitting this application, you certify that you are prepared with all erosion control measures in place for an inspection. Failed inspections are subject to a \$75 reinspection fee.
- Appropriate and required on-site Erosion and Sedimentation Controls and Stormwater Best Management Practices must be followed to reduce erosion, sedimentation & stormwater pollution. Site maintenance is required to maintain compliance.
