#### 2. Discussion of Tentative Millage Rate and Budget

- a. The Town of Indian River Shores tentatively proposes an aggregate millage rate of 1.3349 per \$1,000 for the Fiscal Year 2024-2025.
- b. The tentative millage rate of 1.3349 is necessary to fund the expenses included in the budget and is **10.29% higher** than the rolled-back rate of **1.2104**
- c. The 2024-2025 tentative General Fund budget is \$10,838,870 which is 22.53% higher than last year.
- d. The other funds in the 2024-2025 budget are tentatively set as follows:
  - 1) Roads and Offsite Drainage Fund of \$120,076; and
  - 2) Planning, Zoning and Building Fund \$1,044,500.
