2. Discussion of Tentative Millage Rate and Budget

- a. The Town of Indian River Shores proposes an aggregate millage rate of 1.2402 per \$1,000 for the Fiscal Year 2026-2027.
- b. The final millage rate of 1.2402 is necessary to fund the expenses included in the budget and is **2.84% higher** than the rolled-back rate of **1.2059**.
- c. The 2026-2027 General Fund final budget is \$10,896,569.
- d. The other funds in the 2026-2027 final budget are set as follows:
 - 1) Roads and Offsite Drainage Fund is \$99,804;
 - 2) Solid Waste Special Assessment Fund is \$385,033 and
 - 3) Planning, Zoning and Building Fund is \$1,168,975.

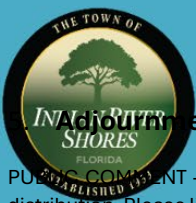
