#### 2. Discussion of Tentative Millage Rate and Budget

- a. The Town of Indian River Shores tentatively proposes an aggregate millage rate of 1.3349 per \$1,000 for the Fiscal Year 2023-2024.
- b. The tentative millage rate of 1.3349 is necessary to fund the expenses included in the budget and is **12.25% higher** than the rolled-back rate of **1.1892**
- c. The 2023-2024 tentative General Fund budget is \$8,845,576 which is 12.69% higher than last year.
- d. The other funds in the 2023-2024 budget are tentatively set as follows:
  - 1) Roads and Offsite Drainage Fund of \$129,112; and
  - 2) ARPA Fund of \$654,190; and
  - 3) Planning, Zoning and Building Fund of \$998,865.
